On 07-04-2011, I was present at my house. my husband Ratno Bheel went towards Bhatti Hotel to visit his relatives. I sent my daughter shrimati Dhanni to agricultural land near home to collect ladyfingers. It was morning time about 08:00am, my daughter Dhanni returned at home while shouting/crying and informed that two persons namely Nisho son of Bhooro Kolhi and Ramji son of Shamoo Bheel have forcibly committed Zina with me in Banana crop and then gave poison, and she became unconscious while stating the facts. I informed about the incident to Jai Ram son of Poonjo Bheel son of Poonjo and after arranging transport, we proceeded to hospital. On the way her mouth was closed and in the hospital she expired. We have took her back to village, where Munshi Raja Meghwar was informed and he was asked to intimate police. He suggested for burial of dead body and promised for justice within three days by Panchait/ Faista. He adjourned one pretext to other, we also went to landlord Maqsood Qaimkhani but he did not help us. Then after consultation with relatives now I have come for report. Action may be taken.</p> <p><u>Investigation detail:</u> Respected Sir, it is respectfully submitted that the investigation of this case was initially conducted by the then SIO SIP Ghulam Muhammad Hingoro, who prepared memo of site inspection, recorded statements of witnesses & respectable persons of locality.</p>

Police picket was arranged at the grave. Letters were sent to court and DG Health for exhumation. The date i.e. 26-05-2011, was fixed for conducting postmortem of deceased Dhani but was adjourned as the Civil Judge/ JM was on course. Again date i.e. 09-06-2011 was fixed and on 09-06-2011, exhumation of grave was held in presence of doctors and civil judge & JM Tando Allahyar, but dead body was missing from grave. Thereafter, statement U/S.164 Cr.P.C of witness Jai Ram was got recorded and tried to search the dead body. On 14-06-2011, the then SIO proceeded on leave and investigation of this case was conducted by ASI-Muhammad Bux Majeedano, who tried to search the required absconding accused and dead body of deceased Dhani and got further time for submission of interim. As per investigation of this case, section 201 PPC was added against the accused persons due to missing of dead body. As per investigation of this case, I.O. found the accused persons involved in the offence, hence prepared challan against the arrested accused Nisho Kolhi and absconding accused Ramji Bheel and submitted before the court of law.
