Report of complainant is that, I am Student of 2nd Year B.A, in Girls College Dadu and reside at above mentioned address. Namely Fayyaz Meerani had demanded my hand one month back, to whom my father Muhammad Ali Jhutiyaal had refused to give my hand to him, upon which, he became annoyed. Before this, he forcibly confined me in a place and forcibly committed rape (Zina) with me and made video, while blackmailing me said, if you narrated this matter to any one, I would upload your recorded video on Internet, due to fear of defamation, I remained silent. Today on 25-10-2014, I alongwith my father Muhammad Ali S/o Ali Nawab Jhutiyaal were going to Girls College by Rickshaw, when at about 11-1/2 Hours, reached near Girls College Dadu at old National Bank Dadu and saw that one grey colour car came in

front of us, that namely each Fayyas S/o Shabbir Ahmed by caste Meerani, 2) Iqrar S/o Manzoor by caste (word illegible) both Resident of Najmi Colony, Dadu alighted from the said car, in the meantime, accused Fayyaz Meerai took out pistol from his fold, aimed at us and asked for calm, we remained silent due to fear of weapons; accused Fayyaz Meerani forcibly got me down from Rickshaw by taking from my arms, then, both accused on the strength of weapons forcibly got me sit in car, folded my eyes and took away me to unknown place. Where confined me in a place and forcibly removed my clothes on bed lying inside the room and accused Fayyaz Meerani also stripped off his clothes, caught hold my both legs, and forcibly penetrated his penis and committed rape with me. When I raised cries, accused put hands on my mouth, after discharging accused Fayyaz worn clothes and said to Iqrar hurry up this is Gharibabad Mohallah; saying so, both accused persons went away by boarding in Car parked outside. Then, having worn my cloths, came out from place, by taking conveyance came at P.S, where ASI Muhammad Umer Wigyio shifted and got conducted my medical check up from WMO Civil Hospital Karachi on behalf of Women Police. I narrated such facts to my elders, after consultation. I have appeared to report at P.S that accused Fayyaz Meerani forcibly kidnapped and have committed rape (Zina) with me. I am complainant, investigation be made.
