FACTS OF FIR

U/s. 365-B - 376 PPC.,:

I have appeared to lodge the complaint that; accused persons namely: Fayyaz Mirani and Iqrar Janwri, both R/o Najam Colony, Dadu having got alighted me forcibly from Rickshaw from Old NBP, Dadu, took in car, confined me in a place situated in Gharib Abad Mohallah, Dadu, accused Fayyaz Mirani has committed Zina (Rape) with me forcibly. I am lady complainant, investigation be made. Further facts would be revealed from the FIR.

Sir,

It is submitted that the ASI. Ghulam Muhammad Panhwar of PS., A - Sec., having lodged said case forthwith, sent the copy of FIR to woman A - Sec., for further investigation, ASI. Muhammad Umer Vaghio, woman A - Sec., Dadu has conducted the investigation of said case, he immediately has issued letter to WMO, Civil Hospital, Dadu for medical checkup of lady complainant Mst. Benazir Jhuttial, Mashirnama of clothes of lady case complainant has been prepared, I/O has inspected the place of offence and Mashirnama regarding place of offence has been prepared, the (Not in focus) of lady case complainant have been received from the WMO, Civil Hospital, Dadu while the clothes of lady complainant have been sent to Karachi for chemical analysis, the I/O having arrested to accused wanted in the said case named Iqrar Janwri on 28-10-2014, has obtained remand from Honorable Court, statement U/s. 161 Cr. P. C. of eye witness of the said case named Muhammad Ali Jhuttial was recorded, he mentions in his statement that the accused mentioned in FIR named Iqrar Janwri is innocent and at the time of abduction of his daughter, Iqrar Janwri was not present there while his daughter Benazir has nominated to Iqrar Janwri due to any enmity, he is innocent, the I/O has also obtained the statements of more witnesses namely: Muhammad Ramzan S/o Ghulam Rasool Cheema, R/o (Not in focus) Abad Mohallah, Dadu and Aamir Ali S/o Noor Muhammad Leghari, R/o Najam Colony, Dadu, they have disclosed that at the date and time of offence, Iqrar Janwri was together with them in Sehwan Sharif, he is innocent, so, due to non - availability of any evidence upto the Challan against accused Iqrar Janwri, as per orders of the Higher

Officers, he has released U/s. 497 Cr. P. C., the I/O has tried his best efforts to apprehend the wanted accused Fayyaz Mirani, but, the accused Fayyaz Mirani prior to arrest has got granted bail from the Court of IIIrd Addl. Sessions Judge, Dadu, he is on bail by the Court, the (Not in focus) and clothes of lady complainant raped in the said case have been sent to Karachi for chemical analysis, from where, chemical report could not receive. As per investigation conducted by the I/O and as per statements of witnesses, complete evidence of the said offence upto the Challan has proven against the accused Fayyaz Mirani, on the strength of past evidence, the case documents were submitted to the Higher Officers for approval of Challan, from where, approval has been received for Challan U/s. 344 Cr. P. C. of the said case, therefore, having prepared the Challan U/s. 344 Cr. P. C. of the said case, the same is submitted before the Honorable Court in the interest of justice, on receiving chemical report of lady case complainant, report U/s. 173 Cr. P. C. will be submitted before the Honorable Court, FIR of the said case has already been submitted before the Honorable court, Copies of statements and mashirnamas are enclosed herewith in order to supply to the accused.
